Purpose of assembly: To protest the closure of a pedestrian footpath between Heidelberg and Northcote Streets which forces pedestrians to take a long and inconvenient detour which is not accessible for people in wheelchairs.

Proposed route: March on the left-hand inbound lane of Lytton Rd from the south-east corner of the Heidelberg-Lytton intersection to the south-east corner of the Northcote St-Lytton Rd intersection. Pedestrians will move safely onto the roadway when traffic has been stopped by the green pedestrian signal at Heidelberg-Lytton. The purpose of this assembly is to protest the council's decision to close the footpath without providing a safe and accessible alternative route for pedestrians. As such it is fundamental to the nature of the protest that the procession takes place on the roadway.
